MINUTES CITY OF THORP REGULAR CITY COUNCIL MEETING MONDAY, MAY 8, 2017 AT 6:30PM IN THORP CITY HALL

1. Call to Order/Pledge of Allegiance

The meeting was called to order at 6:30pm. In attendance were Mayor Stroinski; Alderpersons Cowley, Lawcewicz, Abramczak, Rosemeyer, and Wnek; DPW McCredden; Deputy Clerk-Treasurer Pogodzinski; Police Chief Schneider; Library Director Beloungy; and City Administrator Reeg.

2. Presentation of the FY2016 Audit by Jon Trautman of Schenck

Trautman briefly reported on the audit. He reported that fund balance was healthy, rates of return for the water and sewer utilities were improving, and that the general audit process continued to get easier. As always, he offered that he was available year-round if any of the elected officials had questions or concerns. No action taken.

M/M/S (Lawcewicz, Wnek) to change the June meeting of the City Council to June 5th. Carried on a 4-1 vote with Alderperson Abramczak voting no.

7. Resolution 2017-05-1 "Resolution Awarding the Sale of \$1,910,000 General Obligation Corporate Purpose Bonds, Series 2017A"

Brian Reilly from Ehlers was on hand to give results of the bond offering and to discuss the schedule pf remaining steps to be taken.

M/M/S (Wnek, Rosemeyer) to adopt the resolution. Carried by a unanimous roll call vote.

- 8. <u>Discussion and possible action to adopt certain chapters of the Police Policy and Procedure Manual M/M/S</u> (Wnek, Lawcewicz) to adopt Sections 100, 300, 304, 306, 308, 311, 604, 900, and 1009. Carried unanimously.
- 9. <u>Resolution 2017-05-2 "Resolution Authorizing Conveyance of Real Estate to Jason and Shelly Frankewicz"</u>

M/M/S (Wnek, Rosemeyer) to adopt the resolution. Carried unanimously.

10. <u>Resolution 2017-05-3 "Resolution Authorizing Conveyance of Real Estate to Brian and Shannon Grendzinski"</u>

M/M/S (Rosemeyer, Abramczak) to adopt the resolution. Carried unanimously.

11. <u>Resolution 2017-05-4</u> "Resolution Authorizing the Purchase of Real Estate from James R. and James D. <u>Heling</u>"

M/M/S (Rosemeyer, Cowley) to adopt the resolution. Carried unanimously.

NEW BUSINESS

12. <u>Resolution 2017-05-5 "Resolution Approving Pay Application #1 from Haas Sons Inc. for 2017 Street 7 Utility Improvement Project"</u>

M/M/S (Lawcewicz, Wnek) to adopt the resolution. Carried unanimously.

13. <u>Discussion and possible action relating to clarification of Employee Sick Leave Accrual and Retiree</u>
<u>Health Insurance policies and implications on OPEB liability</u>

Reeg and Trautman explained that since the time when the city first adopted these policies, there has been new GAAP accounting standards put into place that focused on Other Post-Employment Benefits (OPEB). The city's current policy needed clarification to determine OPEB implications.

M/M/S (Lawcewicz, Wnek) to amend the policy to delineate that retirees must acquire their own individual health insurance policies at retirement and only then could be eligible for reimbursement for premiums paid from sick leave balances until the earlier of depleting the balance or becoming eligible for Medicare. Carried unanimously.

- 14. <u>Discussion and possible action relating to ITA for lead service replacement grant money</u> It was agreed by general consensus to apply for these grant monies.
- 15. <u>Discussion and possible action relating to proposed park rental fee increase from Park & Rec Board M/M/S</u> (Lawcewicz, Rosemeyer) to approve the recommended fee increase. Carried unanimously.

16. <u>Discussion and possible action relating to possible vacation of street right of way on E. Grant St.</u> It was agreed by general consensus to move forward with the vacation process.

M/M/S (Lawcewicz, Wnek) to reconvenes in to open session. Carried unanimously.

M/M/S (Lawcewicz, Wnek) to approve an Operator's License for Daniel R. Samaniego on a 1-year probationary basis. Carried unanimously.

M/M/S (Lawcewicz, Rosemeyer) to set Schneider's salary at \$52,500. Carried unanimously.

Dewey McIntire (400 E. Stanley St., Thorp) questioned a bill received for snow removal. Reeg noted that a meeting of the Public Works & Utilities Board would be convened, at which he could appeal his bill. No action taken.
